**Improving Houston's Quality of Life Series, Part IV:  
*Improving Quality of Life Through Better Infrastructure Investments***

With federal funding for U.S. infrastructure becoming increasingly scarce, states and localities are scrambling to piece together other sources of financing, including the private sector. Please join us as Tom Murphy, ULI Senior Resident Fellow and Klingbeil Family Chair for Urban Development, discusses several factors that could contribute to solutions to the infrastructure funding shortfall, including: 1) better connections between land use and transportation planning; 2) public policies that address linkages between areas within an urban region; 3) increased private financing of infrastructure; 4) greater emphasis on the relationship between infrastructure investment and quality of life; and 5) political leadership on infrastructure investment. Prior to joining ULI, Murphy served three terms as the mayor of Pittsburgh, from January 1994 through December 2005. During that time, he initiated a public-private partnership strategy that leveraged more than \$4.5 billion in economic development in Pittsburgh.
